President's Remarks

Alvin Johnson, AD&D 2022-2023 President, of Prairie View A&M University, called the meeting to order at 12:39pm MT. Alvin Johnson thanked the attendees for being present. Alvin again introduced the 2022-2023 executive committee and thanked them for their services.

Financial Report (Linda Maule, Indiana State University)

Linda Maule of Indiana State University, AD&D 2022-2023 Secretary/Treasurer, provided the 2022 Financial Report to the meeting attendees. She reported the following:

Balance Sheet – as of December 31, 2022

The following is an overview of AD&D financial activities as of December 31, 2022:

• The Total Assets for AD&D were \$6,373.94.

Profit and Loss – as of December 31, 2022

The following is an overview of AD&D's income and expenses for 2022:

- Income for 2022 totaled \$40,983.84.
 - o AD&D revenue streams include:
 - Annual Meeting registration
 - Membership Dues
 - Webinar Registration from Non-Members
 - Career Center
- Expenses for the fiscal year total \$42,539.41.
- Net Operating Income for the fiscal year totaled -\$1,555.57.
 - AD&D realized a loss in 2022 as it worked to rebound in its first post-COVID year and return to in-person annual meetings. AD&D experienced a reduction in membership and attendance due to budget cuts of existing and past members.

At the time of the report, AD&D's assets total \$24,244.80.
